**October 9, 2022:** Voter registration deadline.

## Voting

Early and absentee voting are options available to all voters.

**October 29, 2022:** Early voting and in-person absentee voting begins. Deadline to request absentee ballot.

**November 7, 2020:** Deadline to request online or fax ballot

**November 8, 2022:** Election Day, deadline to return electronic absentee ballots, and deadline to postmark mailed absentee ballots.

A valid form of identification is required to vote.
