October 31, 2022: Registration Deadline Same day registration and voting available.

Voting

Every voter receives a mail ballot.

October 17, 2022: First day that mail ballots may be mailed to voters.

November 8, 2022: Election Day and deadline to return mail ballots by 7:00 p.m.

ID Requirements

All voters who vote at the polls must provide identification. If you are voting by mail for the first time, you may also need to provide identification.

Polling Place Details

Polling places are open from 7:00 a.m. to 7:00 p.m.
