**October 11, 2022**

## Voting

All registered Indiana voters are eligible to vote early in-person.

**October 11, 2022:** In-person absentee voting begins.

**October 27, 2022:** Deadline to request an absentee ballot by 12:00 p.m.

**November 7, 2022:** In-person early voting ends at 12:00pm.

**November 8, 2022:** Election Day and deadline to return absentee ballot by 6:00 p.m.

## ID Requirements

A government-issued photo ID is required for all voters.

## Polling Place Details

Polling places are open from 6:00 a.m. to 6:00 p.m. Polling hours are based off local time zones.
