Register

October 18, 2022: There is no cut-off date for registering to vote in person at your town office or city hall. For the General Elections, voter can submit registration by mail by October 18, 2022.

Voting

There are no requirements for an absentee ballot; voting absentee is an option available to all voters.

October 11, 2022: In-person absentee voting begins.

November 3, 2022: In-person absentee voting ends.

November 3, 2022: Deadline to request an absentee ballot.

November 8, 2022: Election Day and 8:00 p.m. deadline to return absentee ballots.

ID Requirements

Maine does not require a photo ID to vote in an election. Identification is required for first time registrants.

Polling Place Details

Polling places are open between 6:00 a.m. and 8:00 a.m., depending on the town. All polling places close at 8 p.m.
