Register

October 11: Regular registration closes; however, you can still register and vote in the election by late voter registration at your county election office.

Voting

Any registered voter may vote by absentee ballot.

October 11: Absentee Voting begins.

November 7: Late voter registration deadline and deadline to request absentee ballot by 12:00pm noon.

November 8: Election Day and deadline to return absentee ballot by 8:00 p.m.

ID Requirements

Identification is required for all voters. For a complete list of acceptable identification, contact your county elections officials or visit the website.

Polling Place Details

Polling places are open from 7:00 a.m. to 8:00 p.m.
