October 15, 2022: Deadline to register to vote. Voter registration on Election Day is also available.

Voting

Absentee ballots are available for voters with a valid excuse.

November 7, 2022: Deadline of 12:00 p.m. to request absentee ballot online.

November 8, 2022: Election Day and deadline of 8:00 p.m. to return absentee ballot.

ID Requirements

Identification is required for all voters. You may sign an affidavit, under oath in lieu of presenting an id.

Polling Place Details

Polling places open between 6:00 a.m. to 11:00 am and cannot close before 7:00 p.m.
