Register

October 18, 2022: Voter registration deadline.

Voting

Early voting and vote-by-mail are available to all voters.

October 29 - 6, 2022: Early voting available.

November 1, 2022: Deadline to request to receive vote-by-mail ballot by mail.

November 8, 2022: Election Day, deadline of 8:00 p.m. to return vote-by-mail ballot in-person, and deadline to postmark mailed vote-by-mail ballots.

ID Requirements

New Jersey does not require a photo ID to vote in an election.

Polling Place Details

Polling places are open from 6:00 a.m. to 8:00 p.m.
