Register

October 11, 2022: Voter registration deadline. Same-day voter registration also available.

Voting

There are no requirements for an absentee ballot; voting absentee is an option available to all voters.

October 11, 2022: Early and absentee voting begins

November 3, 2022: Deadline of 5:00 p.m. to request an absentee ballot

November 5, 2022: Early voting ends

November 8, 2022: Election Day and absentee ballots must be returned by the closing of polls (7:00 p.m.).

ID Requirements

New Mexico does not require a photo ID to vote in an election. Identification is required for first time registrants.

Polling Place Details

Polling places are open from 7:00 a.m. to 7:00 p.m.
