Same-day voter registration is available during early voting and on Election Day.

#### Voting

With the passage of Assembly Bill 321 during the 2021 Legislative Session, all registered voters will receive a ballot by mail.

October 22: Early voting begins

November 4: Early voting ends

**November 8:** Election Day and absentee ballots must be returned in-person by 7:00 p.m. If returned by mail, ballots must be received by November 12, 2022

#### **ID Requirements**

If you are a first-time voter and did not provide an acceptable form of ID with your registration form, you may be asked to show ID at the polls.

#### **Polling Place Details**

Polling places are open from 7:00 a.m. to 7:00 p.m.
