October 11: Mail and in-person

October 11: Online

Same-day voter registration is available during early voting and on Election Day.

Voting

With the passage of Assembly Bill 321 during the 2021 Legislative Session, all registered voters will receive a ballot by mail.

October 22: Early voting begins

November 4: Early voting ends

November 8: Election Day and absentee ballots must be returned in-person by 7:00 p.m. If returned by mail, ballots must be received by November 12, 2022

ID Requirements

If you are a first-time voter and did not provide an acceptable form of ID with your registration form, you may be asked to show ID at the polls.

Polling Place Details

Polling places are open from 7:00 a.m. to 7:00 p.m.

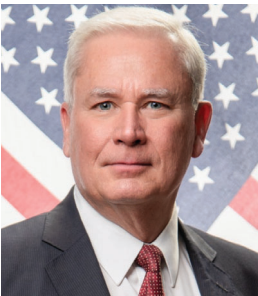
