Voting absentee is an option available to all voters. You can vote early at the County Election Board office in the county where you are registered to vote.

October 24, 2022: Deadline to request an absentee ballot by 5:00 p.m.

November 2, 2022: Early and in-person absentee voting begins at 8:00 a.m.

November 5, 2022: Early and in-person absentee voting ends at 2:00 p.m.

November 8, 2022: Absentee ballots must be received by 7:00 p.m.

ID Requirements

Identification is required for all voters at the polls.

Polling Place Details

Polling places are open from 7:00 a.m. to 7:00 p.m.
