October 9, 2022: Voter registration deadline.

Voting

Early voting and mail ballot voting is available to all qualified voters.

October 18, 2022: Deadline of 4:00 p.m. to request mail ballot.

October 19, 2022: Early voting begins.

November 7, 2022: Early voting ends.

November 8, 2022: Election Day and deadline to return mail ballots by the closing of the polls (8:00 p.m.).

ID Requirements

Rhode Island requires all voters to present valid photo identification prior to voting at the polls in all elections.

Polling Place Details

Polling places are open from 7:00 a.m. to 8:00 p.m.
