October 24: Voter registration deadline.

Voting

Any registered voter may vote by absentee ballot.

September 23: Absentee voting begins.

November 7: Deadline of 5:00 p.m. to request an absentee ballot.

November 8: Election Day. Deadline of 7:00 p.m. to return absentee ballot.

ID Requirements

Identification is required for all voters.

Polling Place Details

Polling places are open from 7:00 a.m. to 7:00 p.m.
