## Voting

All active registered voters will automatically receive a ballot in the mail.

**October 25, 2022:** Early in-person voting is available at certain locations.

**November 8, 2022:** Election Day and deadline for postmarked ballots to be returned by 8:00 p.m. Post office must receive postmarked ballots by November 21, 2022.

### **ID Requirements**

If you are not already registered to vote and are voting with a provisional ballot, you will need to show TWO acceptable forms of ID: one that verifies identify AND one for proof of residence.
