Registered voters may vote absentee by mail or early in-person at your local registrar's office.

Register to vote or apply for an absentee ballot online using the Citizen Portal.

October 28: Deadline to request absentee ballot by mail is 5:00 p.m.

September 23: In-person absentee voting begins.

November 5: In-person absentee voting ends

November 8: Election Day and deadline of 7:00 p.m. to return absentee ballots.

ID Requirements

Voters must provide an acceptable form of ID or sign and ID Confirmation Statement at the polls.

Polling places are open from 6:00 a.m. to 7:00 p.m.
