October 24, 2022: Registration Deadline

Voting

Absentee voting is available to all voters.

September 23, 2022: In-person absentee voting begins.

November 7, 2022: In-person absentee voting ends and deadline to request absentee ballots.

ID Requirements

Effective July 1, 2021, Wyoming voters will be required to show an acceptable form of identification when voting in person. Visit the WY elections website for a list of acceptable identification.

Polling places are open from 7:00 a.m. to 7:00 p.m.
